A. Personal Statement:

I was diagnosed with breast cancer in 1994. I quit my job as a research microbiologist and devoted myself to advocacy. I received training at NBCC, Susan G. Komen, AACR and through the UCSF breast SPORE program. I formed a non-profit in 2001 and now work to train and educate other advocates.

I believe that advocates can play an important role in all stages of the research process by bringing the patient perspective / needs into the discussion early on so no time is lost in course correction. As a UCSF SPORE advocate from 1997 to the present, I have extensive experience working with basic researchers helping them move ideas into the translational field. I am currently an advocate consultant for a DoD grant that will use information from a mouse model to help design a new ultrasound-screening machine that will eventually move into clinical trials. I have been a cooperative group advocate since 2001.
